
Global Manager Commentary

Global cash, measured by USD overnight interbank rate, indicated its value as a risk-management tool over September outperforming all other major global asset classes. Developed market cash rates remain low or negative and does not offer investors enough return potential to intice them to lower risk in their portfolio. Global property stocks detracted more than other major asset classes over September. The detraction has been due to souring risk sentiment toward the asset class following the default of Chinese property group Evergrande as well as several other major Chinese property developers. The price of Brent Crude Oil jumped by a further 4% over the month, further spurring fears of inflation.

Investment Objective & Strategy

Deliver a return equal to or greater than CPI + 6% p.a. over rolling five year periods while keeping the portfolio standard deviation below 12%. Over any rolling three year period the portfolio should always deliver a positive return. The Portfolio is a Multi-Manager solution and will comprise at least two underlying funds and ideally a maximum of six underlying funds. Fund selection will be biased towards funds that have high Sortino Ratios, low downside expectations and have been managed through significant negative equity market conditions. The portfolio will invest in funds that allow the manager to make as many of the asset allocation decisions as possible. Manager selection will balance momentum and value management styles.


