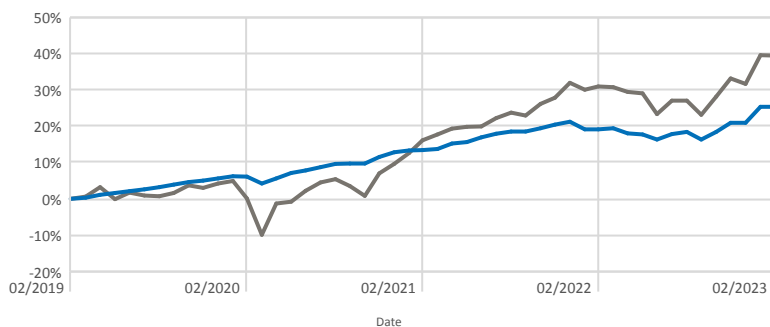
INVESTMENT OBJECTIVE

The Star BCI Balanced Fund's objective is to provide investors with consistent capital appreciation, net of investment fees over rolling six-year periods with no negative rolling 24-month periods and to have the lowest category volatility versus the benchmark. The investment returns generated are evenly balanced between income and capital gains over an ideal investment period of +5 years.

INVESTMENT POLICY

The portfolio will invest in all asset classes including but not limited to equity, bond, money and property markets. The portfolio complies with prudential investment guidelines to the extent allowed for by the Act. The portfolio's equity exposure may not exceed 75% of the portfolio's net asset value and the maximum property exposure is 20% of the portfolio's net asset value. In order to achieve its objective, the investments normally to be included in the portfolio may comprise a combination of assets in liquid form, money market instruments, interest bearing instruments and securities, bonds, debentures, corporate debt, equity securities, notes, property securities, preference shares, convertible equities and non-equity securities. The portfolio may invest in participatory interests or any other form of participation in portfolios of collective investment schemes or other similar collective investment schemes. The portfolio may from time to time invest in listed and unlisted financial instruments.

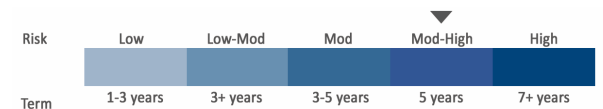

RISK PROFILE



Moderate - High Risk

- This portfolio holds more equity exposure than a medium risk portfolio but less than a high-risk portfolio.
